# 3 Simple Rules for Social Media



## Social media guidelines for NIC United Methodists

John Wesley, the founder of the Methodist movement, lived by and taught three simple rules: Do no harm, do good, and stay in love with God. These simple rules can be applied to many facets of life, including our use of social media. The Minnesota Conference's Extended Cabinet supports the use of social media and believes it can be a valuable tool for ministry. We affirm these guidelines to help use social media in a manner that positively represents the church, the Gospel, and Jesus Christ and that helps us fulfill our Gospel imperatives to grow in love of God and neighbor, reach new people, and heal a broken world.

## *No. 1: Do no harm*

---

One of the benefits of social media is that it provides the opportunity to share views, thoughts, joys, and concerns about all areas of life. Our social media contributions can be very effective tools for ministry if we apply caution before we post. We will be careful that our posts are not “doing harm” by insulting or damaging the reputation of others. We will make sure our posts are respectful and in good taste. And we will remember that everything we post—status updates, comments, tweets, blogs—becomes public immediately after we click “send” (even if we’re using a limited-access setting). We can’t take it back once it’s out there, so we will use discernment with everything we post.

### TO THINK ABOUT

- Is the post “doing harm” to the reputation of the church, Christ, or another person or organization?
- Can the post be interpreted as harmful, offensive, rude, or distasteful? If I’m posting photos, do I have the permission of the people pictured?
- If using the post as an outlet to vent, what’s the most productive and least harmful way to seek resolution or reconciliation? Is there a less public, more respectful way to do so?

## *No. 2: Do good*

---

Social media can serve as an effective method of church networking and communicating. It has the potential to have an encouraging influence on our congregations and communities and to serve as a powerful tool for delivering the Gospel message to a large audience that extends beyond our contact list. It’s also a great way to share news about our church and ministry—and to invite others to join us in worship and service. Additionally, it can be a useful tool for obtaining feedback and ideas from our audience and can be used to gain insight for sermons, Bible study topics, worship times, and needs of the community. The “good” and positive uses of social media are endless.

### TO THINK ABOUT

- Can the post be described as “good”?
- Will it help the kingdom and fellow believers? How will it be perceived by non-believers? How will the post be received by people with different cultural or faith backgrounds?
- Are we communicating effectively by asking questions in addition to providing information?

## *No. 3: Stay in love with God*

---

Social media is a great way to find meaningful devotional materials, thought-provoking blogs, inspiring worship videos and media resources, and current articles and tools for our ministry. Users have reported that their social media usage helps keep them informed and enthusiastic about their ministry on a daily basis. While it can definitely help us “stay in love with God,” it also can be very distracting. We will make sure our use of social media does not occupy so much of our time that we are no longer fully participating in meaningful devotion, worship, Bible study, and conversations with our fellow brothers and sisters in Christ. Social media can serve as a tool to aid, promote, and conduct discussions, studies, and devotional times but should not be our primary source of interaction with the world.

### TO THINK ABOUT

- How is social media helping me to stay in love with God? How is it hindering me?
- How am I helping others stay in love with God by my social media contributions?
- How am I engaging in meaningful interactions that don’t involve social media? When is personal dialogue more beneficial?

Some history on the Rummage and Bake Sale as remembered and submitted by Lavone Gabel:

*Dorothy Shaw organized the first sale to earn money to remove the wall between Fellowship Hall and the next room. Due to some resistance it didn't happen right away. When the wall was finally removed, what a great improvement!*

*A few years later the UMW decided to sponsor the Rummage Sale and make it an "All church rummage and bake sale" with the proceeds going to help with improvements for the church.*

*To name a few of the improvements that have happened past and present:*

- *Remodeled 3 restrooms – approximately \$10,000*
- *Replaced countertops and floor tile, painted the walls, replaced freezer, commercial stove and refrigerator in the kitchen.*
- *Fellowship Hall – light fixtures, painted walls and ceilings, 150 chairs and round tables, electricity on east wall and window blinds*
- *Bus Fund received \$1,000 for insurance, etc.*
- *Carpeting for Library – first time*
- *Painted several rooms over the years*
- *Helped day care.*
- *Vertical blinds for Quilting/Sunday School room upstairs*
- *This past year finished paying for sidewalk replacement, garage roof and water leak between street and church (cut water bill in half) for a total of \$2400.*

**Finance Committee Minutes – Lena United Methodist Church**  
**February 13, 2017**

The meeting opened at 6:30 p.m. with the reading of Psalms 1-6. Those present were: Mick Flynn, Judy Buchenau, Lois Shelton, Randy and Tam Kryder, Pastor Brian LeBaron, Steve Rothschadl, Larry and Kim Nelson.

The committee reviewed the minutes of January 9, 2017. Discussion followed:

- Hangout insurance – church has insurance coverage. Insurance company requested that the Hangout provide a copy of their liability insurance coverage. Pastor will obtain policy.
- Bus insurance – church has full coverage. No changes were made to coverage at this time.
- Bus- previous review of getting bus was for a 2007 model
- Pastor will work on sending letter to first time givers

Larry moved and Tam seconded that the minutes of January 9, 2017, be approved. Motion carried.

**Old Business:** A special finance meeting was held on Sunday, January 15, 2017. Present were Tam and Randy Kryder, Pastor LeBaron, Mick Flynn, Judy Buchenau, Larry and Kim Nelson. Mick Flynn requested funds for a church family in financial need. The Benevolent fund is the account that is used for this type request. Approximately \$550 would be needed for this request. Motion approved.

Judy Buchenau requested that a member of the finance committee be a signer on the General and Designated Fund checking account, as there are times when the two current signers are not available. The Treasurer and Assistant Treasurer are the current signers. Approval was given to have Finance Chairman Mick Flynn added as signer.

**New Business:** Judy reviewed the Memorial Summary Report of all funds, the designated amounts in each fund available, and purpose of funds. Discussion followed on the procedures to be followed on disbursements of funds and accountability. Kim reported that there are procedures for Solicited, Unsolicited and Memorial Designated Funds which had been approved by church council for use in 2014.

The committee reviewed the procedures document. After discussion it was decided to update the memorial/endowment procedures. Larry moved Tam seconded, and committee approved the following: Memorial and Endowment distribution requires approval by finance committee pending approval by church council and minutes recorded for proper audit. The committee also requested a letter be sent to all committee chairs to go over what is required on ALL financial accounting procedures.

A request was made by Eleanor Holmes for payment of \$1,017 invoice for banners. June Stewart memorial had designated funds of \$3,000 for banners. Banners had been purchased in 2016 with a balance remaining of \$601. Request was made for the additional funds of \$416. Following the discussion, additional funds will be paid from the undesignated memorial fund. Randy moved and Steve seconded. Motion passed four to one. Mick emphasized the importance of following proper documentation and procedures for all expenditures.

Kim reviewed the January 31, 2017, Balance Sheet and Profit and Loss reports. Income for January was \$11,881, and expenses were \$14,406 giving a loss of (\$2,525). January expenses were under budget. February expenses are anticipated to be lower than January's. Treasurer will monitor income before paying bills.

Discussion followed on the benevolent account. Mick requested that the benevolent designated fund be replenished to have funds available for future mission needs. Steven moved and Tam seconded and committee approved that \$500 be moved from memorial mission account to benevolent designated fund.

Kim reviewed the analysis report of contributions for 2014, 2015, and 2016. Also reviewed were the 2016 Audit Funds Balance report, findings, and recommendations. Discussion followed on completing recommendations as requested by audit committee.

- Committee will review all financial procedures and forms
- Expenses will be reviewed by member of finance committee  
Notification will be made to all committees and persons involved with financial transactions about all financial procedures
- Accountant will be asked about backup procedures of bookkeeping/payroll system

Mick requested Kim Nelson be added as a member of finance committee. Randy moved, Steve seconded, and motion carried pending approval of church council.

Mick discussed possible ways that committees could be combined so there would be fewer meetings. Many members are on the same committees making for duplication of issues and needing approvals from committees which may not meet for a month or more. The United Methodist conference held a leadership meeting where one meeting detailed a simplified structure of committees that a few churches in the conference are now using. The pastor will look into this with the Shannon Bethel United Methodist Church as it uses this system. Further discussion will be held at next meeting.

Kim reported that Jake Andrews had moved the rest of PC programs and files to the newer PC. Drive from the old computer will be added to the other PC. The committee approved paying Jake \$100 for his services. The account of administrative miscellaneous expense will be debited.

The next meeting will be Monday, March 6, 2017, at 6:30 p.m.

The meeting closed with a prayer at 8:30 p.m.
